Indeed, one might argue that if your downtown isn't plagued by epic parking sagas and people-packed streets, you're not in a bona fide popular destination! So, please remember this next time you are considering limiting to control parking and density in the commercial zones....Density is a big part of experiencing the authentic charm of a truly popular place!
