pear Mayor, Council Members, Staff - I appreciate the updated status report on our Capital Improvement Projects (CIP) provided by Director SanClemente. As I understand, a number of CIP projects were completed:

CIP 601 Prospect Ave Curb Ramps CIP 606
Longfellow Sidewalk Improvements CIP 698 ADA
Improvements CIP 108 Pay-by-App Parking
Signage (Phase 1) CIP 160 PCH Traffic
Improvements CIP 549 Temporary Beach
Accessible Routes CIP 669 City Park Restrooms
and Renovations CIP 623 Pier Structural
Inspection and Evaluation (Phase 1) CIP 629
Municipal Pier Structural Assessment and Repairs
CIP 660 Municipal Pier Electrical Repairs

Considering staff levels for FY 2023-24 were varied between 60% and 80% which affected the department to deliver projects per the Estimated CIP Project Schedule, I believe there are opportunities to improve this process and communication to the public.

1) Create a Milestone Tracking System so obstacles (ex: funding, staffing, priorities) can be easily identified. Since some projects get delayed year after year, the current schedule only lists Estimated Projection Completion Dates which change quite frequently. The only way to currently track it is to pull up the prior years report.

Agenda Item --Name --Comment --At --2) Reduce time frame for updating nonsuccessful recruitment strategies. A six month process to reclassify staffing positions may create unnecessary shortages. 3) Align CIP Project Schedule with how they are categorized on the city website. The Quick Link provides the community easy access to reporting and status updates in a very helpful manner. 4) Review how projects like CIP 621-Comprehensive Downtown Lighting should be prioritized to increase foot traffic and generate additional revenue. The current schedule delays the project again from August 2023 until the end of fiscal year 25-26. Considering the Economic Development Strategy listed this project as a first year priority, I would hope to see it start sooner. Again, I appreciate the all the work of our city staff. Laura Pena Please keep the 14th St restrooms open 7 days a week, and please do not delay their sorelyneeded renovation! 		Prioritizing various capital programs like Street & Sidewalk Repairs with Facilities Work or Sewer Repair is no mean feat; especially when each of these programs has many underlying projects and the Public Works Department also has many competing operational duties.		
		Staff is doing a lot of hard work but I believe they are not being given adequate direction related to the information needed for a meaningful CIP Study Session.		
		Consequently, the Council and the Public are left in the dark.		
		For instance, where are the Project Start Dates, Original (after design) budgets and the Original Estimated Completion dates listed so they can be compared to the Current Total Project Budgets and Current Total Project Expenditures and Revised Estimated Completion Dates?

Still no decision or action has been made and now another delay? Quite frankly, I am indifferent about the repairs. Just open the thing during the week.
