12	renew the existing assessment district designated as "Hermosa Beach Landscaping and Street		
13	Lighting District 2021-2022" pursuant to the "Landscaping and Lighting Act of 1972", being		
14	Division 15, Part 2 of the Streets and Highways Code of the State of California; and		
15	WHEREAS, the assessment district includes all parcels of land within the City and shall		
16	be redesignated as the HERMOSA BEACH LANDSCAPING AND STREET LIGHTING		
17	DISTRICT 2022-2023"; and		
18	WHEREAS, it is proposed to maintain and operate streets and sidewalks within the		
	assessment district, including the operation, maintenance and servicing of landscaping, lighting		
19	and appurtenant facilities located in and along such streets and sidewalks.		
20	NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF HERMOSA		
21	BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:		
22	SECTION 1. That the City Council hereby redesignates the existing Hermosa Beach		
23	Landscaping and Street Lighting District 2021-2022 as the Hermosa Beach Landscaping and		
24	Street Lighting District 2022-2023.		
25	SECTION 2. That the Director of Public Works is hereby ordered to prepare and file a		
26	report in accordance with Article 4 of Chapter 1 of the "Landscaping and Lighting Act of 1972",		
27	being Division 15, Part 2 of the Streets and Highways Code of the State of California, for the		
28	maintenance and operation of streets and sidewalks within the assessment district, including the		
29	maintenance and operation of success and successing within the assessment district, including the
