2	AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HERMOSA			
3	BEACH APPROVING THE JOINT POWERS AGREEMENT FOR CLEAN POWER ALLIANCE OF SOUTHERN CALIFORNIA AND AUTHORIZING			
4	THE IMPLEMENTATION OF A COMMUNITY CHOICE AGGREGATION PROGRAM			
5	AGGREGATION FROGRAM			
6	The City Council of the City of Hermosa Beach does ordain as follows:			
7	WHEREAS, the City of Hermosa Beach has been actively investigating options to provide			
8	electric services to constituents within its service area with the intent of achieving greater loc involvement over the provision of electric services and promoting renewable energy at			
9	competitive rates:			
10	WHEREAS , on September 24, 2002, the Governor signed into law Assembly Bill 117 (Stat.			
11	2002, Ch. 838; see California Public Utilities Code section 366.2; hereinafter referred to as the "Act"), which authorizes any California city or county, whose governing body so elects, to			
12	combine the electricity load of its residents and businesses in a community-wide electricity aggregation program known as Community Choice Aggregation;			
13	WHEREAS, the Act expressly authorizes participation in a Community Choice Aggregation (CCA) program through a joint powers agency;			
14				
15	WHEREAS, through Docket No. R.03-10-003, the California Public Utilities Commission has			
16	issued various decisions and rulings addressing the implementation of CCA programs, includin procedure by which the California Public Utilities Commission will review "Implementation			
17	Plans," which are required for submittal under the Act as the means of describing the CCA			
18	program and assuring compliance with various elements contained in the Act;			
19	WHEREAS, the Clean Power Alliance of Southern California (CPA) is a joint powers authority			
20	established pursuant to California Government Code section 6500 et seq. and California Public Utilities Code section 366.2(c) and a Joint Powers Agreement ("Joint Powers Agreement"), which			
21	purposes include the following:			
22	To form a Joint Powers Authority known as "Clean Power Alliance of Southern			
23	California" (formerly known as "Los Angeles Community Choice Energy Authority"); and			
24	To specify the terms and conditions by which participants may participate as a group in			
25	energy programs, including the implementation of a CCA program;			
26	WHEREAS , an Implementation Plan Addendum will be submitted for review and adoption by the CPA Board of Directors;

WHEREAS, Community Choice Aggregation by and through CPA appears to provide a reasonable opportunity to accomplish all of the following:

1	To provide greater levels of local involvement in and collaboration on energy		
2	decisions;		
3	To significantly increase the amount of renewable energy available to CPA energy customers;

5	To provide price stability, long-term electricity cost competitiveness and other benefits for the community; and		
6 7	To reduce greenhouse gas emissions related to the electricity sector.		
8	WHEREAS , the Act requires CCA program participants to individually adopt an ordinance ("CCA Ordinance") electing to implement a CCA program within its jurisdiction by and through its participation in CPA;		
10 11	WHEREAS, it is in the public's interest and welfare to establish a CCA program within the City of Hermosa Beach; and		
12 13	WHEREAS, the Joint Powers Agreement expressly allows the City to vote to withdraw its membership in CPA (and its participation in the CCA program) by providing no less than 180 advance written notice to CPA.		
14 15	NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF HERMOSA BEACH, CALIFORNIA DOES HEREBY ORDAIN AS FOLLOWS:		
16 17	SECTION 1. That the recitals set forth above are true and correct and are incorporated as though fully set forth herein.		
18	SECTION 2. Based upon the findings and declarations set forth in this ordinance, and in order to provide businesses and residents within the jurisdictional boundaries of the City with a		
19	choice of power providers and with the benefits described in the recitals above, the City Council		
20	hereby elects to implement a CCA program within the City's jurisdictional boundaries. Upon approval and execution of the Joint Powers Agreement, the City will implement the CCA program by and through the City's participation in CPA).

22 23	SECTION 3. That the City Council hereby approves the Joint Powers Agreement, and directs that the City proceed with the participation in CPA.		
24	SECTION 4. That the City Council declares that, should any provision, section, paragraph, sentence or word of this ordinance be rendered or declared invalid by any final court action in a court of competent jurisdiction or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences or words of this ordinance as hereby adopted shall remain in full force and effect.

27	SECTION 5 That this ordinance shall become effective thirty (30) days after its		

adoption.

1 2	that the ordinance is constitutionally valid and that the ordinance is consistent with the general powers and purposes of the City. SECTION 7. The Mayor shall sign and the City Clerk shall attest to the passage of this Ordinance. The City Clerk shall cause the same to be published once in the official newspaper within 15 days after its adoption. PASSED, APPROVED, AND ADOPTED this 27th day of September, 2022.
