

Overall Sentiment







Re: Keeping the 100% renewable rate.

On the agenda tonight is an item to reconsider the 100% renewable energy. That is the default amount specified when the CCA was approved 5-0 for all the good reasons you articulated in that city council meeting. It would be much easier to go backward and start with 50% renewables and kick the can down the road to another council to change it back later.
