

## RESOLUTION NO. 23-XXXX

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HERMOSA BEACH, CALIFORNIA, AMENDING SECTION 4, PARAGRAPHS (a), AND SECTION 4, PARAGRAPHS (a), (b), and (c), LIMITING THE NUMBER OF RESIDENTIAL PARKING PERMITS TO BE ISSUED TO EACH RESIDENCE; AND INCREASING THE FEE FOR RESIDENTIAL PARKING PERMITS**

**WHEREAS**, the City Council approved the 2019 Coastal Zone Parking Management Study ("Study"), which included recommendations to improve parking management strategies for the City; and

**WHEREAS**, the Study noted that more parking permits are issued than spaces are available and recommends revisions to the program with scaled permit prices to disincentivize the oversaturation of parking permits; and

**WHEREAS**, the City Council finds that the high number of permits issued limits on-street parking for residents and visitors without parking permits and limiting necessary beach access;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF HERMOSA BEACH, CALIFORNIA DOES RESOLVE AS FOLLOWS:**

**SECTION 1.** That Section 4, Paragraph (a) of Resolution 82-4524, shall be amended to read as follows; "Any resident of the Impacted Area in a legally established dwelling unit, and one guest parking permit may be issued for each legally established dwelling unit in the Impacted Area. Proof of residence and valid vehicle registration at that address shall be required. Residential Parking Permits are limited to four per year per residence, to vehicles registered to the residence. One of the allowable four Permits may be issued to a guest vehicle."

**SECTION 2.** That Section 8, Paragraphs (a), (b), and (c), shall be amended to read as follows: First permit - \$50; Second permit - \$75; Third permit - \$100; and Fourth permit - \$150.

**SECTION 3. Environmental Review.** Pursuant to CEQA Guidelines section 15061 (b)(3), it can be seen with certainty that there is no possibility that the activity contemplated by this ordinance may have a significant effect on the

environment. Furthermore, section 15273 of the CEQA Guidelines states that CEQA does not apply to modification of fees by public agencies for meeting operating expenses or financial needs.

**SECTION 4.** This resolution shall take effect immediately.

**SECTION 5.** Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this resolution is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision will not affect the validity of the remainder of this resolution. The City Council hereby declares that it would have adopted this resolution, and each and every section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof is declared invalid or unconstitutional.

**SECTION 6.** Record of Proceedings. This resolution takes effect immediately and that the City Clerk shall certify to the passage and adoption of this resolution; shall cause the same to be entered among the original resolutions of said City; and shall make a minute of the passage and adoption thereof in the records of the proceedings of the City Council of said City in the minutes of the meeting at which time same is passed and adopted. The City Clerk shall keep a copy of same along with such other documents and records of proceedings as may be designated by the City Manager.

**SECTION 7.** The City Clerk shall certify to the passage and adoption of this resolution; shall cause the same to be entered among the original resolutions of said city; and shall make a minute of the passage and adoption thereof in the records of the proceedings of the City Council of said City in the minutes of the meeting at which the same is passed and adopted.
