
**RE: City of Hermosa Beach – Notice of Proposed Sewer Service Charge to Fund Maintenance, Operation, Servicing and Improvements to the City's Sewer Collection System and Public Protest Hearing**

Dear Mr. Bakaly and Honorable Mayor Tucker:

Proposed Sewer Tax of \$115.00 per Parcel to be added to the Property Tax Bill cannot possibly be in compliance with either law. The Sewer Tax will be implemented unless 50% of the property owners file a written protest. New retail businesses will be measured by the use of water for the sewer charge. The truth is regarding the sewer lines in Hermosa Beach, homeowners, business owners, and home/apartment renters should be able to vote on the issue of having Hermosa Beach sewer taxed or not.

Owners of the Quality Inn, the Hampton Inn, the Vons Shopping Center, Swedish Pro-Tech, Ralphs Supermarket, the Ralphs Shopping Center, OneWest Bank, El Pollo Inka Restaurant, Superfine Dry Cleaners, Bay Cities Nails Spa, TruBeauty Supply Center, and Starbucks, to the best of my knowledge most of these businesses or business owners have not had the opportunity to discuss the sewer issue. I suggest that we hold up on making a decision on this sewer tax for ninety (90) days for a complete in-house meeting.
