Dear Mayor Massey, Council and City Manager Gonzales,

I run the Strand almost daily- a quick 30-minute run from 6th street to the end of Hermosa/ Manhattan Beach border and back. I've been running this path since 2001 at all hours of the day. In the last year, the number of electric bikes, motorized skateboards and street bikes going 15-20 miles an hour+ have increase ten-fold and there is no policing. Red lights on the commercial section of the Strand can be flashing and bikes whiz by- and it's not tourists but rather locals who know that the laws aren't going to be enforced. It's easy to disobey the rules because no one is holding offenders accountable. This behavior is making the Strand unsafe for residents and visitors alike.

That is why I am extremely disappointed that the city is considering adding a decomposed granite path to the Greenbelt. The Greenbelt is a treasure and adding a "roadway" will certainly destroy the safe oasis that many residents seek in order to escape the urban overcrowding of Hermosa. The city now wants to "pave paradise and put up a parking lot". A joint 4 hour Parks & Rec/ Public Works meeting was held a few years ago (before my time) and residents were adamant in keeping the Greenbelt intact. I am going to ask Kelly Orta to pull the transcripts from that meeting to forward to you. With a majority of residents against changing the Greenbelt, why is the city moving forward with this project? Why no outreach to ask the residents what they want and if this is how they want their tax money spent. I understand the goal is to make the Greenbelt more accessible. However, how does the city propose to keep bikes off the path and keep the Greenbelt safe from residents out on a stroll? The same staff who currently isn't enforcing Strand rules? With the new pavement walkers, joggers, strollers and pets now will now have to dodge bikes on the Greenbelt. Keep Hermosa Hermosa.... Right?
