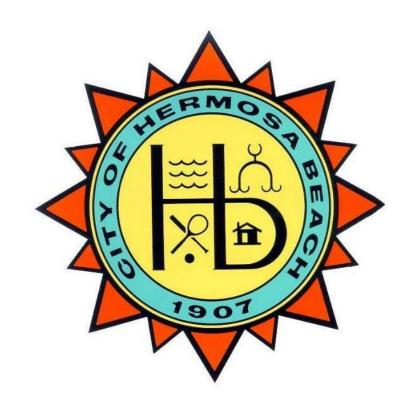
**Assessment**

- Designed for 21,000 volumes; 84 seats - Currently 48,000 volumes; 48 reader seats
- Disabled access issues
- Weak technology infrastructure
- Stacks full to capacity
- Does not meet current county standards
- Inadequate back of house
- Acoustical issues

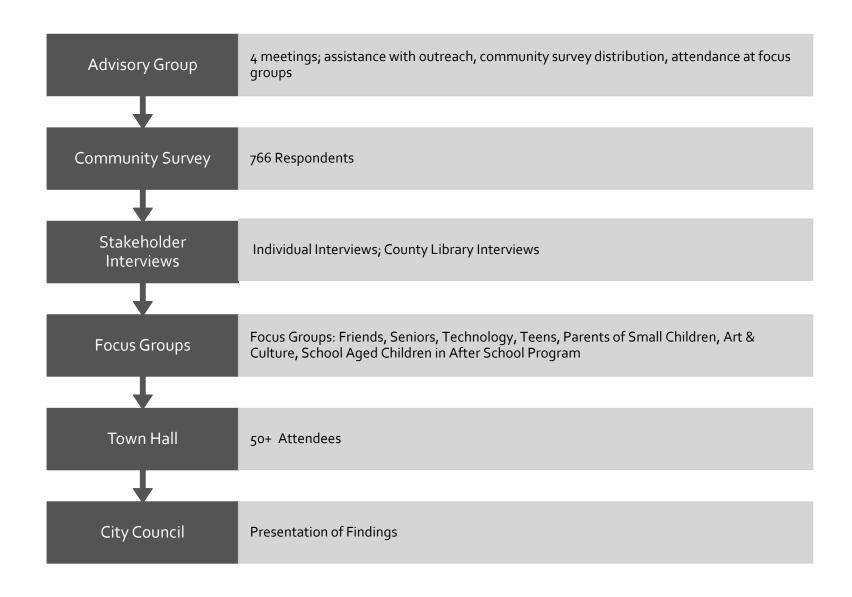

#### **Options**

#### Option 1: Gentle Remodel

- Maintains location
- Maintains operating costs
- Net loss of collections (39K)
- Net loss of seating (40)
- No additional parking
- No multipurpose room
- Added Self-service technology
- New furniture to define functions

## Option 2: 10K Model (with addition or new)

- Increased seating (64) and collections (50K)
- 75 seat multipurpose room
- Group Study Room
- Operating costs increased
- Evaluation of existing facility to determine expansion capacity
- Possible loss of parking at Civic Center

### **Options**

#### Option 3: 11K Model

- New location required
- Operating costs increased
- 100 seat multipurpose room
- .51 SF per capita
- Increased seating (74) and collections (55K)
- Group Study Room (1)
- Friends Sale Area
- Further Analysis Phase 2

#### Option 4: 12K Model

- New location required
- Operating costs increased
- 100 seat multipurpose room
- .6 SF per capita
- Increased seating (96) and collections (6oK)
- Group Study Rooms (2)
- Friends sale and storage area
- Further Analysis Phase 2
