Dear Assemblymember Muratsuchi, Senator Jackson and Senator Lara:

On behalf of the City Council and residents of the City of Hermosa Beach, we want to thank you for your leadership on this very important matter. On January 23, 2018, Hermosa Beach City Council voted to approve and support your recently introduced Assembly and Senate Bills opposing the Federal Department of the Interior's proposed offshore oil and gas resource program.

The City of Hermosa Beach, as a member of the League of California Cities, is officially in support of Assembly Bill No. 1775 as well as Senate Bill No. 834. These companion Bills would prohibit the State Lands Commission and local trustees from entering into lease agreements for exploration or production of oil or natural gas in state regulated coastal waters, up to three miles from the coastline.

In March 2015, eighty (80) percent of Hermosa Beach Residents voted against Measure O, demonstrating the overwhelming opposition of the residents of Hermosa Beach to oil drilling. Supporting Assembly Bill No. 1775 and Senate Bill No. 834 is consistent with this directive as well as the City's 2021 Strategic Plan Goal of a More Livable, Sustainable Beach City.
