

### NOTICE OF HEARING TO ABATE NUISANCE

Notice is hereby given on the 22nd day of May, 2018, the City Council of the City of Hermosa Beach passed a resolution declaring its intention to conduct a public hearing to determine whether that certain premises located upon that certain real property situated in the City of Hermosa Beach, State of California, known and designated as 725 Cypress Avenue, Hermosa Beach, California, 90254, the Crossfit Horsepower Gym, in said City, more particularly described as parcel # 4187-030-008, constitutes a public nuisance which must be abated. If said premises or activities on said premises, in whole or in part, are found to constitute a public nuisance, and are not abated within the time specified by the City Council, the same will be abated by the City, in which case the cost of such abatement will be assessed upon and against the land on which said premises is located and that the cost thereof will constitute a lien upon such land until paid. Said nuisance consists of the following:

- 1. Prohibited vibrations
- 2. Prohibited sounds
- 3. Prohibited noises between the hours of 10:00 p.m. and 8:00 a.m.
- 4. Use of sidewalks and public ways

All persons having any objections to or interest in said matter are hereby advised to attend a meeting of the City Council of the City of Hermosa Beach, to be held in the Council Chamber, City Hall, Civic Center, located at 1315 Valley Drive in the City of Hermosa Beach, California, on the 10th day of July, 2018, at the hour of 7:00 p.m. of said day, when their evidence relating to said matter will be heard and given due consideration.

2	A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HERMOSA
3	BEACH, CALIFORNIA, SETTING A PUBLIC HEARING TO DETERMINE IF THE PROPERTY AT 725 CYPRESS AVENUE
4	CONSTITUTES A PUBLIC NUISANCE
5	THE CITY COUNCIL OF THE CITY OF HERMOSA BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:
7	<b>SECTION 1</b> . State and City statutes provide for the abatement of structures and properties
8	determined to be a public nuisance.
9	
10	<b>SECCTION 2.</b> Chapter 8.28 of the Hermosa Beach Municipal Code contains provisions
11	allowing the City Council to conduct a public hearing to determine whether a public nuisance exists
12	on a property and whether proceedings to abate the nuisance should be initiated.
13	
14	SECTION 3. The City Council has reviewed logs of reports and written evidence of
15	nuisances on the property at 725 Cypress Avenue, Hermosa Beach, and determined that there is
16	sufficient evidence of a public nuisance on the property to set a public hearing to determine if
17	abatement proceedings should be initiated.
18	
19	SECTION 4. Based on the foregoing, the City Council hereby sets a public hearing for July
20	10, 2018 to determine if the above-referenced property constitutes a public nuisance, and directs the
21	City Clerk to advertise the hearing and to notify thereof the property owner and all owners within
22	300 feet of the subject property, pursuant to the abatement procedures outlined in Section 8.28.070
23 24	of the Hermosa Beach Municipal Code.

26	SECTION 5. This Resolution shall take effect immediately. The City Clerk shall certify
27	to the passage and adoption of this Resolution, shall cause the original of the same to be entered




