

1 **C.C. RESOLUTION NO. 18-XX**

2 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF**  
3 **HERMOSA BEACH, CALIFORNIA, AMENDING THE CITY OF**  
4 **HERMOSA BEACH MASTER FEE SCHEDULE TO ADD AN**  
5 **ADMINISTRATIVE FEE RELATED TO THE RELEASE OF**  
6 **IMPOUNDED BICYCLES, SCOOTERS, AND OTHER PERSONAL**  
7 **MOBILITY DEVICES.**

8 **THE CITY COUNCIL OF THE CITY OF HERMOSA BEACH, CALIFORNIA,**  
9 **DOES HEREBY RESOLVE AS FOLLOWS:**

10 **SECTION 1.** The City Council has previously adopted a comprehensive fee schedule  
11 which, establishes certain administrative fees, including fee S-088 related to the release of  
12 impounded vehicles.

13 **SECTION 2.** On August 28, 2018, the City Council adopted Ordinance 18-\_\_\_, an  
14 ordinance regulating shared mobility devices and clarifying regulations on the use of wheeled  
15 devices on the Strand walkway. The City Council desires to specify that a new fee related to the  
16 release of impounded bicycles, scooters, and other wheeled mobility devices be added to the  
17 comprehensive fee schedule in the amount of \$130 and given a code of S-088A.

18 **SECTION 3.** The City Council hereby declares that “bicycles”, “electric bicycle”,  
19 “motorized bicycle”, “motorized scooter”, and “scooter” as the terms are defined in Municipal  
20 Code Section 10.04.010, are subject to the impound vehicle release fees (S-088A) set forth in the  
21 Hermosa Beach Comprehensive Fee Schedule.

22 **SECTION 4.** The City Council is taking action only on those fees, permit fees, City  
23 service charges, and other fees, charges, and required payments for municipal services, use of City  
24 property, inspections, enforcement activities or for other indicated purposes, as modified and as set  
25 forth in Section 3. The (i) remaining fees, permit fees, City services charges, and other fees,  
26 charges, and required payments for municipal services, use of City property, inspections,  
27 enforcement activities or for other indicated purposes as set forth in the current Comprehensive  
28 Fee Schedule; and (ii) fees, permit fees, City service charges, and other fees, charges, and required  
payments for municipal services, use of city property, inspections, enforcement activities or for

1 other indicated purposes as set forth in any resolution(s) adopted by the City Council, that are not  
2 listed in Section 3 of this Resolution, have not been readopted or revised and remain in place at the  
3 current rate.

4 **SECTION 5.** The City Clerk shall certify to the adoption of this Resolution, enter it into  
5 the original records of the City and thenceforth and thereafter the same shall be in full force and  
6 effect.
