## 1 **ORDINANCE NO. 20-1402** 2 3 AN ORDINANCE OF THE CITY OF HERMOSA BEACH ESTABLISHING THE POSITION OF APPOINTED CITY CLERK IN LIGHT OF THE 4 PASSAGE OF CITY MEASURE CC AND ESTABLISHING THE CITY 5 MANAGER AS APPOINTING AUTHORITY FOR THE CITY CLERK 6 The City Council of the City of Hermosa Beach does hereby ordain as follows: 7 8 Section 1. The purpose of this Ordinance is to implement City Measure CC, approved by the electorate at the November 5, 2019 election, changing the City 9 Clerk from an elected to an appointed position in the City government. 10 11 Section 2. Section 2.12.070, subparagraph C. of Title 2, Chapter 2.12 of the Hermosa Beach Municipal Code is amended to read as follows: 12 13 C. Power of Appointment. It shall be the duty of the city manager to, and he or she shall appoint, remove, promote, and demote any and all employees of the city, 14 except the city attorney and city treasurer, in accordance with the City's personnel 15 rules and regulations. 16 Section 3. Section 2.48.010 of Title 2, Chapter 2.48 of the Hermosa Beach 17 Municipal Code is amended to read as follows: 18 2.48.010 Bond of city treasurer. 19 Pursuant to Section 36518 of the California Government Code, the city treasurer 20 shall execute a bond to the city prior to entering upon the duties of his/her office. The penal sum of the bond shall be established by resolution of the city council. 21 22 Section 2.72.050 of Title 2, Chapter 2.72 of the Hermosa Beach Section 4. 23 Municipal Code is hereby repealed. 24 Section 5.
