Recommended Action:

Staff recommends that the City Council direct the City Clerk's office to immediately advertise the three upcoming board/commission term expirations and invite applications from all interested parties.

Summary:

Three Public Works Commission terms will expire October 31, 2020. All three appointments will be for four-year terms ending October 31, 2024. Applicants must be qualified electors of the City (HBMC Section 2.32.010). These seats are currently held by:
