REQUEST FOR APPROVAL OF SPONSORSHIP DONATION TO THE BEACH CITIES HEALTH DISTRICT'S 24th ANNUAL HOLIDAY GIFT BAG PROJECT

Recommended Action:

Staff recommends City Council approve a donation of \$579 to the Beach Cities Health District's Holiday Gift Bag Project for 2022.

Executive Summary

The Beach Cities Health District (BCHD) Holiday Gift Bag Project gift bags filled with practical and fun gifts to beach cities seniors and adults with disabilities each holiday season.

Background:

The Beach Cities Health District (BCHD) Holiday Gift Bag Project is supported through partnerships with local agencies, civic organizations, service groups, private donations, and memorials. As part of the Holiday Gift Bag Project, friendly volunteers have delivered gift bags filled with practical and fun gifts to beach cities seniors and adults with disabilities each holiday season since 1998. Each year, hundreds of volunteers participate and provide joy and excitement to recipients of the gift bags, many of whom are homebound or live in isolation.

Discussion:

For the 2021 holiday season, BCHD provided grocery gift cards to lower income individuals. They also provided stamps, a 2022 calendar, snacks, hand sanitizer, and holiday cards created by youth in the community. For this holiday season, there will be 18 Hermosa Beach residents receiving holiday support through the Holiday Gift Bag project including grocery cards for lower income recipients. The total cost for Hermosa Beach clients is \$579.
